ANSWERS TO VENDORS QUESTIONS & REQUEST FOR ADDITIONAL INFORMATION

This addendum forms a part of the Request for Proposals document for the above-identified project and clarifies questions and requests that have been submitted pertaining to RFP No. 1559-25, specifically pertaining to California Labor Laws. LABOR AND UNION

Q1: Are the current transit contractor employees represented by a Union?

A1: Yes. The current contractor, Transdev, Inc. (formerly First Transit) is represented by Teamsters Local 848. The current Collective Bargaining Agreement (CBA) expires in June 2027. The current subcontractor, Secure Transportation, is not represented by a Union.

Q2: Does California Labor Code 1070 apply?

A2: As the current contractor workforce is represented, California Labor Code 1070 will apply.

Q3: Please provide information on the current employees for the existing transit contract.
