NOTICE TO VOTERS OF DATE AFTER WHICH NO ARGUMENTS FOR OR AGAINST CITY MEASURES MAY BE SUBMITTED TO THE CITY CLERK/ELECTIONS OFFICIAL

NOTICE IS HEREBY GIVEN that a General Municipal Election will be held in the City of Cerritos on Tuesday, March 4, 2025, at which there will be submitted to the voters the following Measures:

Measure J: Voter Approval Required for Election Date Change and Related, Conforming Amendments	
Shall the Cerritos City Charter be amended to require that voter approval must be obtained for any future change to the City's general municipal election date, currently established as the first Tuesday after the first Monday in March of each odd-numbered year, and make conforming amendments to the start date of each City Council member's term and selection date of the Mayor, relating thereto? Measure K: Comprehensive Charter "Clean Up"	
Shall the Cerritos City Charter be amended to remove or modify provisions based on superseding and preemptive State law, increase Citywide operational efficiency by eliminating references to outdated business practices, and correct grammatical, punctuation, and spelling errors?	YES

NOTICE IS FURTHER GIVEN that pursuant to Article 4, Chapter 3, Division 9 of the Elections Code of the State of California, the legislative body of the City, or any member or members thereof authorized by the body, or any individual voter or bona fide association of citizens, or any combination of voters and associations, may file a written argument, **not to exceed 300 words in length**, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, for or against the City measures.

PLEASE NOTE: All authors of the written argument must print his/her name and sign the argument itself and print his/her name and sign the "Form of Statement to be filed by authors of arguments" which is attached with this notice and available by request free-of-charge in the Office of the City Clerk/Elections Official by visiting the Office at City Hall or by request sent via email to election2025@cerritos.us.

NOTICE IS FURTHER GIVEN that, based upon the time reasonably necessary to prepare and print the arguments and Voter Information Guide for the election, the City Clerk/Elections Official has fixed **Monday, October 21, 2024, during regular office hours, as posted**, as the date after which no arguments for or against the City measures may be submitted to the City Clerk/Elections Official for printing and distribution to the voters as provided in the Article 4. Arguments shall be submitted to the City Clerk/Elections Official, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, at the Office of the Cerritos City Clerk/Elections Official, 18125 Bloomfield Avenue, 1st Floor, City Hall, Cerritos, California. Arguments may be changed or withdrawn until and including the date fixed by the City Clerk/Elections Official, which is **Monday, October 21, 2024, during regular office hours, as posted**.

NOTICE IS FURTHER GIVEN that any ordinance, impartial analysis, or direct (primary) argument filed under the authority of the elections code will be available for public examination in the City Clerk/Elections Official's Office for not less than 10-calendar days from the deadline for the filing of the arguments and analysis(es).
