SERVICE OVERVIEW

Continuation of eligibility-based Dial-A-Ride service

Replacement of City's traditional fixed-route service with general public on-demand service

Including peak-hour (a.m. and p.m.) service linking Cerritos with Metro's C Line Station in Norwalk and Metrolink's Norwalk/Santa Fe Springs station

- Curb-to-curb, shared-ride
- Cerritos residents age 55 and older
- Persons with disabilities regardless of age
- Monday–Friday: 8:00 am to 8:00 pm
- Saturday–Sunday: 8:00 am to 5:00 pm



DIAL & RIDE

DIAL-A-RIDE: THREE-TIER SERVICE AREA

• Tier 1:

Cerritos, Artesia, and portions of La Palma and Norwalk

• Tier 2:

Service to medical facilities within three miles of Tier 1 boundaries

• Tier 3:

Service to approved medical facilities outside Tier 2 boundaries (chiefly Long Beach)

- North: Alondra Blvd
- East: Valley View Ave
- West: Palo Verde Avenue
- South: Del Amo Blvd
- Corner-to-corner (virtual stops)
- Curb-to-curb: ADA-certified persons





- City seeking turn-key model (RFP, page 5)

- Target wait-time: 20 to 30 minutes
- Service hours: Monday–Friday 7:00 a.m. to 7:00 p.m.




